Characteristics of Dordon Primary School

Dordon Primary School is a small primary school situated in North Warwickshire on the outskirts of Tamworth. The school catchment includes one of the most deprived wards in the borough and faces considerable socio-economic challenges; the catchment has significant levels of deprivation. Most pupils are of White British heritage with only 6% speaking English as an additional language, which has remained stable in recent years. The percentage of children eligible for free school meals is above the average for the Borough.

In July 2024, two children classed as Child In Need and three children subject to Early Help, three children looked after and 1 formerly in care. However, these figures are constantly changing.

Unfortunately, domestic violence, drug and alcohol abuse, neglect and poor housing are factors that frequently have to be overcome. Pupil mobility is stable with similar numbers of children leaving and arriving this year. The majority of these are due to house moves.

Mobility often has a dramatic impact on continuity and progression of education for individual pupils.

The percentage of children eligible for free school meals is above the average. 68 children were entitled to PPG (32%) all of these are currently in receipt of FSM. 58 children (27%) were on the school's SEN register, 7 with an Education, Health and Care Plan (EHC Plan). In addition, 41% of the pupils on the SEN Register were also entitled to PPG
